Meta ei ew eochun fichin arongorong?

Ka era eom kewe popun ngeni emon chon angangen arongorong ina ii ESE KAN ew pekin ewe WIC Program. Ei emon aramas epwene fori ew finata ina a kan eochuno fichin me pwan epwene asinei ngonuk me pwan ewe WIC Program ren an ewe mwan/febin finata.
- Ew tungor ren ew eochun fichin arongorong epwene kan forita me non 60 ran seni ewe ranin ewe ngawen fofor a kan titiwow seni posto ika ngeni emon chon aeoeo ika chon fitinong.

Ei ese kan aeoeo ngeni chon aeoeo kena ra pinepineo seni aninis kena non apoputan afateno, chon fitinong kena ina ar attun fansoun afateno a kan sopweno ika chon fitinong kena ina ra kan tetenino pwe rese nafeno ren aninis kena.
