Meac se inge, pacl in lohngyuck ma wo ac suwohs?

- Ke sie pacl in lohngyuck ma wo ac suwohs, ac utuckot nuhsun sie pacl wo in fwackwack srihpac lom ma pwacnacng kom nuhnuh kuh muh Prokracm luhn WIC tiac oruh suwohs orekma laltahl nuhsun. Kom ac ahkkahlwemye srihpac lom an nuhsin sie mwet orekma (hearing official) ma TIAC wi Prokracm luhn WIC. Mwet se ingacn ac oraclah sie sulaclah ma wo ac suwohs na elac tuh ahkkahlwemye nuhsun ac Prokracm luhn WIC ke sulaclah se lal an.
- Enenuh kom in oruh siyuckyuck nuhke sie pacl in lohngyuck wo ac suwohs ke lusen lwen 60 liki pacl se ma ma inge supweyucklac ke lwacta kuh ituckyang nuhsin sie mwet nwacna kuh mwet ma wi ipeis.

Yac ngac srackna wi eis kashruh ke WIC Food Benefits?

- Mwet suc oruh siyuckyuck in sifwil lohngyuck ke srihpen tulohkihnye eisyacn mwe kashruh ke luse lwen singel lihmekohsr ke mahlwem (15), liki pacl se ma lwacta in tulokihnye eis kashruh lom an oreklac, mwet sacn ac tahfwelah na eis kashruh liki Prokracm sac nwe ke na hearing official sac oraclah sulacлах lal kuh mitinh se omeet an sahflah. Sie na sin ma inge ma orek meet. Ma inge tiac orekma nuhsin mwet nwacna pwepuh ma tiac fihlfihllac in eis kashruh ke miting se emeet, mwet wi ipeis ma pacl in miting se emmet laltahl an ahluhkwelah pacl kuh mwet wi ipeis ma acwac oacna mwet suc tiac kuh in eis kashruh. Mwe nwacna pwepuh ma tiac fihlfihllac in eis mwe kashruh ke miting se meet an (kuh suc ahluhkwelah tari miting se emeet an) ac kuh in sifiwl siyuck in longyuck ke srihpen itucklac eltahl, tuh eltahl ac tiac kuh in eis mwe kashruh ke lusen pacl eltahl sano in eis pacl in lohngyuck laltahl.
