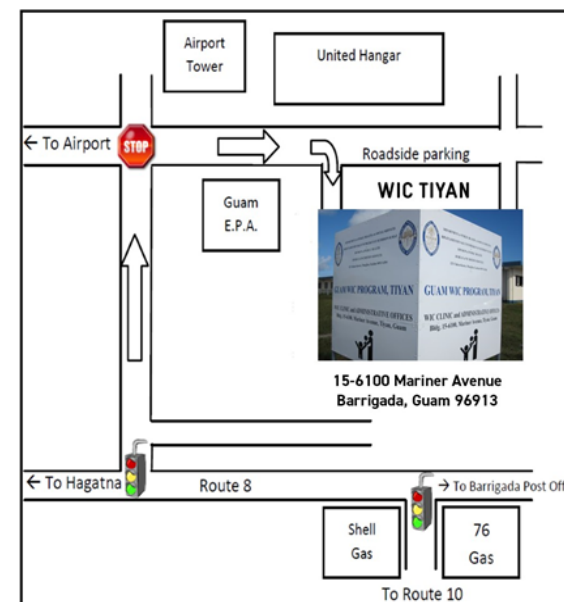
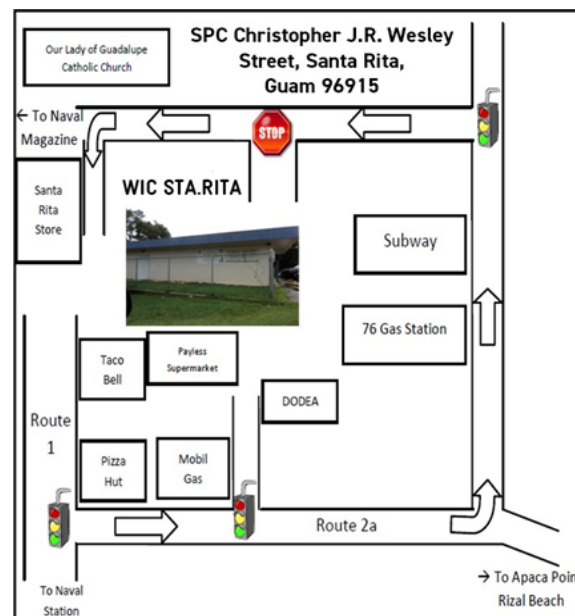
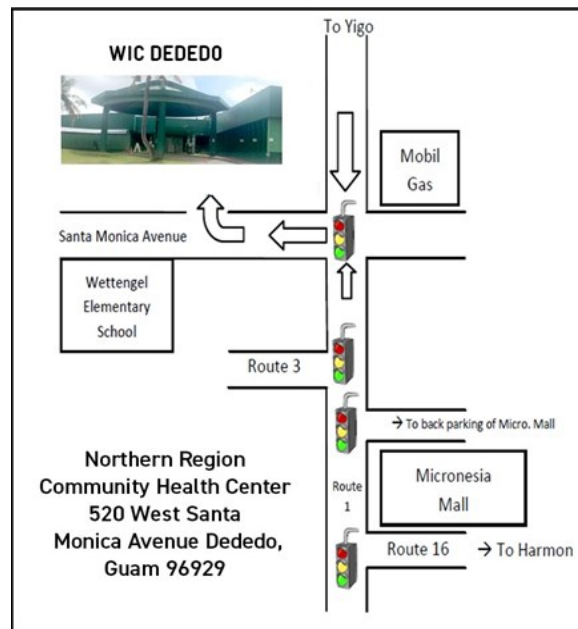

HEALTHY FOOD

Through WIC moms get monthly benefits to buy healthy food, such as:

- Foods with calcium for strong bones and teeth
- Grains with iron for energy, and folic acid for healthy growth
- Fruits and vegetables to keep your heart and weight healthy
- Foods with protein for strong muscles and healthy skin
- Iron-fortified foods for infants who need it

NUTRITION EDUCATION

We support and educate moms to help them breastfeed successfully. We offer guidance on how to shop for healthy food, how to prepare it and how to entice children to eat it. We provide access to information, including:

- Prenatal nutrition
- Breastfeeding tips
- Eating tips for your child
- Parenting tips
- Healthy recipes

A COMMUNITY OF SUPPORT

We're a network built for moms. We connect them, we educate them and we learn from them. Our community consists of:

- Nutritionists
- Lactation specialists
- Breastfeeding Peer Counselors

REFERRALS

We can introduce moms to resources outside of WIC, including:

- Healthcare professionals such as pediatricians, OB/GYNs, and dentists
- Immunization services
- Substance abuse counselors
- Domestic abuse counseling
- Social services

WHO CAN APPLY?

You can apply if you are:

- Women: Pregnant, postpartum (up to 6 months after infant's birth), or a breastfeeding woman (up to infant's 1st birthday)
- Infants: A parent/guardian for an infant (0-11 months old)
- Children: A parent/ guardian for a child under 5 years old.

WHAT TO BRING TO YOUR APPOINTMENT?

Bring the following to your certification or first appointment::

- Two (2) most recent paycheck stubs of every-one working and/or retired in the household. Any proof of cash income such as child support, tips, or LES document
- Current proof of ID
 - » For adults: Valid Guam ID, or Guam Driver's License, or passport, or work or school ID
 - » For Infants: crib card, or hospital birth certificate, or official birth certificate, and immunization card or shot record
 - » For Children (under 5 years old): official birth certificate and immunization card/shot record
- Proof of Residency such as utility/cable bill, or lease/ rental agreement, or Mayor's verification letter, or Real Guam ID, or Real Guam Driver's License, or note from your homeowner with supporting name and home address.
- Bring the Infant and/or child under 5 years old
